### General

- **BIG CASH PRIZES AWARDED TO TOP THREE FINISHERS:** Winner \$1,800.00, 1<sup>st</sup> Runner Up \$900.00, and 2<sup>nd</sup> Runner Up \$300. Third, fourth, and fifth place runner ups will each receive a gift certificate.
- Contestants must be 16 years of age or older. If under 21 years of age, a parental guardian must also sign off on your application and abide by all stipulations.
- **ALL JUDGE'S DECISIONS ARE FINAL! NO EXCEPTIONS!** The Sunman Chamber of Commerce will attempt to get local, musically talented individuals to be the judges, however, if this is not possible, all contestants must abide by the judges decisions regardless if they have musical background/talent or not. Again, this is for entertainment purposes only and will somewhat mirror the TV show "American Idol". This year the Sunman Chamber of Commerce has decided to allow the audience to pick a "Fan Favorite" amongst the 6 finalists! The audience may have a "pay-per-vote" opportunity. To vote for your "Fan-Favorite" it will cost \$1 per vote. The contestant who receives the most votes will be named the "Fan Favorite". The Fan Favorite may or may not be the Idol winner, or an Idol runner up, but will be one of the six finalists vying to win the title of "Sunman Idol". The Fan Favorite will receive one half of the money raised for them in their box. All other monies will go to the Sunman Chamber of Commerce to help with the expense of the Idol competition and general wine & fireworks festival expenses.
- The Sunman Area Chamber of Commerce is NOT promoting a music career, advancement, opportunity, future sponsorship, or anything else related to the already mentioned, for purposes of furthering the contestants' career. **AGAIN THIS IS FOR ENTERTAINMENT PURPOSES ONLY WITH A NICE PAY OUT OF CASH FOR TOP FINISHERS AS DECIDED BY OUR JUDGES & IDOL COORDINATORS.**

### Specifics

- Contestants will perform a cappella (no background music), 1 verse & 1 chorus, the night of auditions held on Saturday, August 21st, 2010 starting at 6:00 pm at the Sunman American Legion Hall, Post 337. Contestant check-in this night is from 5:00 pm – 5:45 pm. This audition is held indoor & will be open to the public for viewing; there is a small admission fee. Light refreshments to include food, soda and beer will be available for sale to benefit the Sunman Chamber of Commerce and the Sunman American Legion.
- The audition night will not be limited to a specified number of contestants unless the Sunman American Legion Organization determines that auditions are exceeding time limits of the Legion hall rental.
- Regardless of entries, only 12 contestants will be asked to return to perform at the semifinals on Saturday, September 4<sup>th</sup> at the Sunman Community Park starting at 1:00 pm and anticipated to last until 3:00 pm, in conjunction with the Sunman Wine & Fireworks Festival. This performance is held outdoor. Contestant is to sing the full song with background music via CD or musical instrument.\*
- On Saturday, September 4<sup>th</sup> at the Sunman Community Park starting at 8:00 pm & anticipated to last until 9:00 pm, will be the final competition with the 6 finalists, again in conjunction with the Sunman Wine & Fireworks Festival. The anticipated time to announce the Sunman Idol winner & runner ups is prior to or immediately following the fireworks show at approximately 10 pm. This performance is held outdoor. Contestant is to sing the full song with back ground music via CD or musical instrument.\*
- If contestant advances to the semifinals or finals, the contestant must sing a different song at each performance, but the contestant may sing a song from the same artist.
- Contestant's entry fee is \$15.00 due upon submission of registration form. It is preferred that registration forms & payment are submitted prior to audition

night, however registration forms and payment will be accepted the night of auditions during the registration time of 5:00 – 5:45 pm. Registration forms & payment may be picked up & dropped off at the Sunman FCN Bank, McPhersons, ETC, John Watson Law Office, Sunman Town Hall, or Tha Store Café. - There will be a \$5.00 spectator's fee per spectator 16 years or older (\$1.00 for children under the age of 16 years old) or \$20 per family on Saturday, August 21st at the Sunman Legion Hall. There will be no spectator fees collected at the semifinals and finals on Saturday, September 4<sup>th</sup> at the Sunman Community Park in conjunction with the Sunman Wine & Fireworks Festival.
- Contestant agrees to allow photos, audience video taping, and use of name at any time during this event without any expectation of compensation.

\*For the semifinals and finals contestants are permitted & encouraged to have background music via a CD or musical instrument to accompany contestant's voice. Contestant is required to provide their own CD. If contestant is using a musical instrument to accompany their voice, the contestant must play the instrument themselves. Contestant is required to provide all equipment, cords, necessary hookup, etc. which will plug into our professional sound system. Please avoid instruments that may be elaborate and time consuming to hookup.
